#### ANR Plan:

### **Sherman Farms:**

The Board is in receipt of the ANR Plan for Sherman Farms. This was reviewed by the Town Planner and recommends endorsement.

## ANR Plan 39 Buffon:

### **Cobbler's Knoll Amendment:**

Engineer Steve O'Connell was present to discuss the Cobbler's Knoll. The topic of discussion was work which needs to be addressed. The amendment covenant was for 8 building permits. The fire cistern needs to be filled. This was completed. The basin drain pipe needs to be capped or removed. This was a concern of the Conservation Commission. The basin and swale in phase 1 was finalized. There will be a site visit with the Conservation Commission. The swales are functioning but need to be cleaned up and shaped to make sure the water is conveyed properly. There is a concern about the down stream with the erosion near the basin. The velocity is coming down at a rapid rate. There needs to be a resolution of this. The Board was reminded that at the previous meetings, the bond was accepted and there was a release of lots. There continues to be a concern about the site distance at the entrance road. The revised covenant will be reviewed. There was a suggestion to hold the occupancy permits. The applicant is not the builder of the homes since the lots have been sold and the builder is the same one as in phase 1. The Board wants there to be routine maintenance of basin 1. There needs to be reports and inspections

provided. The Engineer communicated that the basin will be rebuilt in 30-45 days. There needs to be monitoring.

On a motion made by Craig Haringa, seconded by Lauren Steele, the Board voted unanimously to amend the covenant and will sign the document. This will be held until the bond is provided.
