

**Minutes of the Board of Health Meeting Thursday, March 7, 2013 at 3:00 pm Selectmen's
Meeting Room, Lower Town Hall**

Present: Wayne Tucker, Chairman, Peter Baghdasarian, Member. Also present Denise Delannoy, Admin Asst.

Meeting to Order: Being after 3:00 pm and the meeting having been duly posted, and a quorum being present, the meeting was called to order by Wayne Tucker, Chairman.

Old Business: None

New Business:

Joan MacKinnon, complaints regarding roosters at 38 Brown Terrace:

Persons giving statements: Joan MacKinnon, Bruce Desilets, Joyce Feen, Nancy Feen, Jane Mitchell, Michael Baril, and Dick Feen.

Joan MacKinnon gave the Board a copy of the transcript of the recent court case involving Jocelyn Smyth in regard to the roosters at 38 Brown Terrace crowing.

Joan MacKinnon referenced several pages of the transcript noting that some mistakes were made. Wayne Tucker admitted to mistakes as this was the Boards first experience bringing an action to court.

Joan MacKinnon asked if the Board was willing to enforce their regulations in particular BOH Article IX, regulation 5. No person shall keep or allow to be kept any number of domestic animals which shall constitute a nuisance.

Several persons in the arena gave testimony that they have heard the roosters crowing. The board was asked to reopen this case, and take action to alleviate the nuisance crowing.

Motion: Peter Baghdasarian to continue this agenda item to a future meeting in order for Jocelyn Smyth, 38 Brown Terrace, to give testimony. Seconded, Wayne Tucker.


Reduce fee for Stable Permits from \$50.00 to \$25.00.
