**Minutes of the Uxbridge Board of Health meeting held on Wednesday, March 8, 2017 in the Board of Selectmen meeting room, 21 S. Main Street, Uxbridge, MA at 5:00 pm**

**Present:** Chairman Michael Morrisette, Jonathan Neitz, Member, James Smith, Member.

**Also present,** Kristin Black, Health Agent and Denise Delannoy, Admin. Asst.

**Meeting to order:** The time being 5:05 pm and the meeting duly posted with a quorum present Chairman Morrisette called the meeting to order.

**Old Business:**

Kristin Black advise that the condemnation order for Elmwood Ave. has been lifted. There are still some concerns to be addressed there.

**New Business:**

The Board and Health Agent discussed working on a Soil Importation Regulation.

**Motion:** Jonathan Neitz that James Smith and Kristin Black would work with Jay Talerma to draft a Soil Importation Regulation. **Seconded,** James Smith. The vote was unanimous.

The Board and Health Agent discuss issuing a letter to the Ma DEP regarding the soils testing at 175 South Street.

**Motion:** James Smith to issue a letter to Mass DEP expressing our concerns with the project at the 175 South Street site. The inadequate soils and ground water testing and failed and cancelled test results. The project poses a significant threat to public health. **Seconded,** Jonathan Neitz. The vote was unanimous.

The Board and Health Agent discuss issuing a letter to MA DEP regarding the soils testing a 775 Millville Road.

**Motion:** Jonathan Neitz that we issue a letter to MA DEP noting our concern about the project at 775 Millville Road and reminding them that we have not received any information requested by the letter that we sent June 2016. **Seconded:** James Smith. The vote was unanimous. Also remind that any correspondence mentioning the Board of Health must come from the Board of Health office and that there is no other department that represents the Board of Health. The project poses a significant threat to the public's health. **Seconded:** Jim Smith. The vote was unanimous.

**Motion:** Jonathan Neitz to accept the minutes of 2/13/2017. **Seconded,** Michael Morrissette. The vote was unanimous.


**Motion:** Jonathan Neitz to accept the minutes of 2/22/2017. **Seconded,** James Smith. The vote was unanimous.


**Residents' Concerns:** Patrick Hannon questioned the Board on their training and other disparaging remarks.

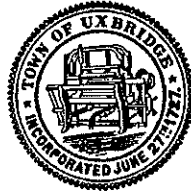
