Kristin Black with update on housing complaints, 33 School Street, all trash has been removed.

99 Elm Street abandoned for past 10 years, complaint through Building Inspectors Office. An Order to Correct will be drawn up and the Abandoned Housing Initiative Office will be contacted.

Soil Importation Application and Approval, Kristin Black reviews regulations as being directly out of the Soil Importation Regulation.

Motion: David Tapscott to accept the application for soils importation following some small edits and have it reviewed by the Town Manager and Town Counsel. **Seconded**, Michael Morrisette. The vote was unanimous.

Kristin Black, update on sharps disposal equipment and policy.

At present, the sharps containers will be free. The expectation is that it would remain free of charge until the supply diminishes, approximately fifteen months.


