

**Any other business which may lawfully come before the Board –**


The Board requested Ms. Butler to continue on the Planning Board as a full member.


Also, the Board discussed re-educating themselves about the current bylaws and review the bylaws at each meeting.


The Board noted that Executive Session will not convene.
