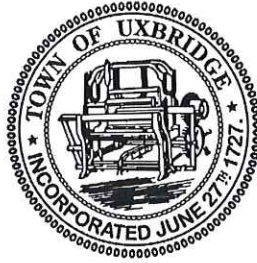

**1. REGULAR BUSINESS**

**• Vaccination Clinic Updates**

Michael spoke with Tony Giunta from Hannaford. Tony submitted forms to apply for receiving COVID-19 vaccine and setting up clinics. Tony doesn't know as yet how many vaccine doses they will be able to receive each week. He needs a commitment from the Town of Uxbridge stating it has a location for the clinic and volunteers to help with logistics. He also said he has five nurses available to vaccinate.

Hannaford will be handling PrepMod (the State's COVID-19 vaccination software), vaccinators, vaccines and liabilities. The Uxbridge Board of Health will be offering logistical support, site, and list of people interested in getting vaccinated. A letter will be drafted by the Board of Health for Hannaford. They are very eager to be working with the community to get as many people vaccinated as possible.

The Board thinks that McCloskey Middle School may be an appropriate location for Hannaford to hold

their clinics. The set up can be left up between clinics since the building is not in use.

Michael will draft a letter to Chief Tom Dion of UXFD to request an EMT and ambulance on site at all vaccination clinics. The suggestion was made that each town involved in the clinics rotate EMT and ambulance on site.

Erin Hightower received approval to start the process of applying for vaccines on Monday 2/1/21. Diane Legere has set up a survey on the Uxbridge website to gather information of residents from Uxbridge, Northbridge, Douglas and Mendon so that when we are ready to begin clinics we will have their contact information. As of 1/28/21 more than 2,000 surveys have been filled out. Diane will reach out to Mike Potaski of Uxbridge-Millville Regional Housing Association, Patrick Stephan of Summerfield (who has inquired about a clinic on site), Linda Kelly from Uxbridge Housing Authority and Lisa Bernard of Uxbridge Senior Center to work on other locations for helping seniors filling out surveys and book appointments when clinics are up and running. Erin has also received funding through Central Massachusetts Regional Planning Commission for vaccination clinic costs.
