Mr. Kevin Bostrom with Camping World present and provided an update on his business. They will be purchasing Flagg RV and continuing business as usual. Campers World is looking forward to coming to Uxbridge. No one from the public wished to speak.

d) PUBLIC HEARING: Alcohol License: Retail On Premise All Beverages: Depot Cafe Inc, 115 Main St.

MOTION: Mr. Plasko move that the Board of Selectmen open the public hearing Alcohol License for Depot Cafe Inc., 115 Main St. Second by Mr. Mandile. Roll Call Vote: Plasko YES; Mandile YES; Shaw YES; Butler YES. Motion carried 4-0.

Matt Tyrrell from Depot Cafe updated the Board on his plans for expansion with liquor service. No one from the public wished to comment.

MOTION: Mr. Plasko move that the Board of Selectmen close the public hearing for Depot Cafe Alcohol License. Second by Mr. Mandile. Roll Call Vote: Plasko YES; Mandile YES; Shaw YES; Butler YES. Motion carried 4-0.

The Board thanked Mr. Tyrell for his expansion. MOTION: Mr. Plasko move that the Board of Selectmen approve the retail on-premise all beverages license for Depot Cafe, 115 Main Street. Second by Mr. Mandile. Roll Call Vote: Plasko YES; Mandile YES; Shaw YES; Butler YES. Motion carried 4-0.

e) Marijuana Host Community Agreement: Rhythm of Life

Principals Kristofer Artz, Brett Hanson, Sara Williamson along with Attorney Blake Mensing were all present. Proposing Tier 1 Cultivation and Manufacturing at 217 River Road. 7200 sq. ft. Mr. Artz updated the Board on bringing his business to Uxbridge and looking forward to contributing to the community.

MOTION: Mr. Shaw move that the Board of Selectmen direct the Town Manager to negotiate a community host agreement with Rhythm of Life Inc. to operate a marijuana cultivate business in the Town of Uxbridge. Second by Mr. Mandile. Roll Call Vote: Plasko YES; Mandile YES; Shaw YES; Butler YES. Motion carried 4-0.

f) Inter-Municipal Agreement – Building Commissioner for 70-acre parcel accessed via Lackey Dam Road, Uxbridge/ Blackstone Logistics Center

This request is for the Town of Uxbridge to approve an intermunicipal agreement to use the services of the Town of Sutton's Building Commissioner, John Couture, to perform the inspectional duties for the project known as the Blackstone Logistics Center, accessed from Lackey Dam Road and shared by the Towns of Uxbridge, Douglas and Sutton. Mr. Sette discussed the agreement with the Board. Uxbridge would not be doing the inspections. The Board had concerns on Sutton taking all the fees. Building Inspector Larry Lynch, stated that 51.5% of the building is in Uxbridge and the Uxbridge building fee would be \$235,941.52. The Board would like Mr. Sette to reach out to Sutton to negotiate terms of the agreement. The Board will discuss at a future meeting date after Mr. Sette has reached out to Sutton.

MOTION: Mr. Plasko move that the Board of Selectmen accept the donation of \$1,000 to the Senior Center and the \$500 Fire Department donation from Ruth Lewcon with thanks for her generosity. Second by Mr. Mandile. Roll Call Vote: Plasko YES; Mandile YES; Shaw YES; Butler YES. Motion carried 4-0.
