 - i. Human services: 610, 510, 541, 543

Mr. Sette will ask Ms. Troast to send out information regarding the Municipal Liens Certificate fees.

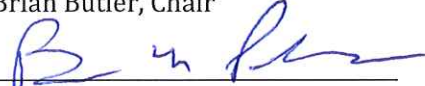
2. Adjournment 9:21 p.m.

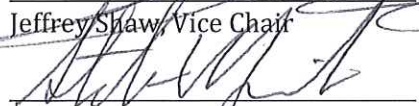
