- 1) Street name Approval: Subdivision off of 85 Chestnut Street
 Proposed name: Trainer Road. The developer of the property at 85 Chestnut Street has selected
 the name of Trainer Road, named after William Trainer whose name is on the Uxbridge Wall of
 Honor. MOTION: Mr. Shaw made a motion that the Board of Selectmen approve the street
 name Trainer Road for the street in the subdivision at 85 Chestnut Street. Seconded by Mr.
 Mandile. The motion carried 5-0-0.

ARTICLE 3: BLACKSTONE STREET WELL FIELD/RTE. 16 WATER LOOP ENTERPRISE FUND

- Right of First Refusal: Intent to Sell: Local Initiative Program (LIP) 1 Adams Court. The Board received a letter from the owner indicating their intent to sell and included an email from MA DHCD outlining the sale price and process.
 - MOTION: Ms. Franz made a motion that the Board of Selectmen decline to exercise the Town's right of first refusal under the Local Initiative Program, of the property at 1 Adams Court in Uxbridge. Seconded by Mr. Shaw. The motion carried 5-0-0.
- 7) Marijuana Cultivator Host Community Agreement: (taken out of order after 2) Announcements b) Uxcellent News)

Conception Nurseries, 56 Industrial Drive, Unit A. Blake Messing, Attorney for Conception Nurseries present. Requesting a Host Community Agreement for cultivation (2-5 inch plantlets).

MOTION: Ms. Franz made a motion that the Board of Selectmen authorize Conception Nurseries to enter into negotiations with the Town Manager for a Host Community Agreement for a marijuana cultivator business at 56 Industrial Drive, Unit A, Uxbridge, MA. Seconded by Mr. Shaw. The motion carried 5-0-0.

 - a. Police Department: Zoll AEDPlus® (Automatic External Defibrillator) donation by Six10 AED of Mendon valued at \$1200.

MOTION: Mr. Plasko made a motion that the Board of Selectmen accept with thanks the donation from ZollAED Plus of an Automatic Defibrillator to the Police Department. Seconded by Mr. Shaw. The motion carried 5-0-0.

b. Community Garden – Shed donation by Barbara Hall & Ed Maharay MOTION: Ms. Franz made a motion that the Board of Selectmen accept with thanks the donation by Barbara Hall and Ed Maharay of a garden shed to be used by the Uxbridge Community Garden. Seconded by Mr. Plasko. The motion carried 5-0-0.

- d) Letter to NPS re Adams site: Mr. Hechenbleikner has sent a letter to the National Park Service to

- support the application of the Adams burial site for recognition by the NPS.
- e) Streetlights turning them back on and converting all to LED lights: Mr. Hechenbleikner has signed the necessary documents with National Grid to have all "red-capped" street lights turned back on, and to have all street lights converted to LED lights. The total cost per year will be significantly less than budgeted. Process will take 6-9 months for service to return.
- f) License Update: One Day Liquor license: Our Lady of the Valley Parents Guild: 75 Mendon Street: 11/23/19: Mr. Hechenbleikner has issued a one-day liquor license to Our Lady of the Valley Parent Guild for November 23, 2019.
