

TOWN OF UXBRIDGE BOARD OF SELECTMEN MEETING MINUTES LOCATION: REMOTE MEETING UXBRIDGE, MA

1) CALL TO ORDER & SALUTE TO THE FLAG

The meeting was called to order at 6:30 PM by Mr. Butler. The Pledge of Allegiance was recited.

Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, § 18, and the Governor's March 15, 2020, Order imposing strict limitations on the number of people that may gather in one place, this meeting of the Uxbridge Board of Selectmen was conducted via remote participation. a) Charter Communication License Expiration: Vote to authorize Cable Advisory Committee, Town Manager, and Town Counsel to negotiate license on behalf of the BOS.

- b) 100-Acre Lot Cropland Use Discussion
 - Brian Palmer
 - Justin Harshaw

The Town has the 100-acre lot that is currently used regularly for activities like, the soccer field, the community gardens, and dog park; and there is still a significant amount of unused land, and the Town has received two proposals from parties who operate farms in the area who are interested in using part of this land in their farm operations. One proposal is from a group of three farmers: Harshaw Cattle Company, Hawkes Dairy & Greener Acre Farms, and Cedar Hill Farm who are requesting the use of approximately 45 acres; and the other proposal is from Brian Palmer who is requesting the use of approximately 10 acres.

Both Mr. Harshaw and Mr. Palmer were present on the call, provided an overview and answered questions from the Board. Mr. Harshaw had forwarded an updated proposal late this afternoon, so the Board postponed to its next regular meeting on July 13, 2020. Mr. Sette will follow up with Town Counsel for their review.

c) Social Media Policy

The Board of Selectmen has received a complaint from the Board of Health of an apparent violation of the Town's social media policy by a Finance Committee member. Mr. Sette reminded all boards and committees of the policy purpose and the importance of compliance. The Board requested Mr. Sette request that Town Counsel, review, investigate, and advise follow-up measures. This agenda item will be postponed pending the completion of these activities.

- a) Union Contracts Discussion Mr. Sette provided Board members with the status of ongoing negotiations with the unions.
- b) State Reopening Update Mr. Sette provided an update on establishments who have applied for and been approved for outdoor expansion; 5 for food and alcohol and 3 for food only. The food and alcohol approvals are: The UXLocale, Kapi's Pub, Quaker Tavern, Meadowview Tavern/Blissful Meadows, and the VFW on Cross Road. The food (no alcohol) expansion approvals are: Mom's Restaurant, The Burger Grille, and The Valley Bean.
- c) Town Meeting and Town Budget Mr. Sette thanked everyone involved in preparing for Town Meeting and the Town Budget, including the Board of Health, Kelly Cote, Town Clerk, Ellen Welch and Erin Lemoine, Michelle Laramee, Lisa Troast, the Finance Committee, the Board of Selectmen, Valley Chapel, and Pastor Matt and Pastor Josh, and Town Moderator Ed Maharay; and, most importantly, to all the residents of the Town of Uxbridge who prepared and participated and ensured the meeting went as smoothly as it did. Mr. Butler echoed Mr. Sette's comments and offered thanks to all involved in both the Town Meeting and Town Budget processes.
- d) Mr. Sette reminded everyone the warrant for the Fall Town Meeting will be opened on July 27, 2020. That warrant will close on August 28, 2020. The FATM will be held on October 27, 2020.
