This meeting was held in-person & via Zoom.

**Present:** Chairman Brian Butler, Vice Chairman Jeffrey Shaw, Clerk Stephen Mandile, Members Peter DeMers and John Wise

1) <u>CALL TO ORDER</u> – Butler called the meeting to order at 6:30 PM. The Pledge of Allegiance was recited.

#### 2) ANNOUNCEMENTS

#### 3) <u>CITIZENS' FORUM</u>

- a) Paul Balutis, 40 Taft Hill Lane, regarding the on-going marijuana odor issue with Cresco Labs, their HCA, and their plan for odor control.
- b) Rory St. Pierre, 42 Taft Hill Lane, regarding the same marijuana odor issue as stated above with added notation that the time of odor is unpredictable and sporadic.

#### 4) TOWN MANAGER UPDATE

- a) Turner Farm Road: Jack Hunter, Town Planner, present via Zoom to update the Board with the background of this project. The residents living there have been without Town Services since the beginning of the project and Hunter stated concern with the coming winter season. Extensive discussion occurred; Town Planner, Hunter, to speak with Town Counsel on the lack of communication from the project developer and how to mitigate the issues moving forward.
- b) Cresco Update: Odor mitigating plan to be reviewed by a third-party consultant, Tech Environmental, with the potential to extend their services to HCA review in the future; the scope of services has been sent with an agreement to follow soon.
- c) Sutton Street Fields: Hay and Harrow bid went out with no response and mention of a misunderstanding; this project will be re-bid sometime next week.
- d) Early Voting has begun!

#### 5) **BUSINESS**

a) Continuation: Blackstone Watershed Collaborative

The Board previously heard from a representative of the Blackstone Watershed Collaborative but delayed acting on a motion of support for when there was a full seated Board. After discussion regarding the Resolution and Watershed Collaborative occurred, the Board unanimously agreed to take No Action as the Resolution has no teeth and serves no beneficial purpose.

VOTE: that the Board take no action on this item. All in favor. The motion carried 5-0-0.

- b) Uxbridge Surplus Equipment Vote to Accept:
  - i) UCTV Surplus Equipment
  - ii) Council on Aging Surplus Tables
  - iii) Council on Aging Surplus Equipment: 2008 Mercury Sable

On an annual basis, the Town does its own version of Spring Cleaning to collect any surplus equipment to be offered for sale. The Town uses a third-party vendor, Auctions International, to handle the sale; the vendor will photograph and post the equipment for sale and bids made for the products, with the proceeds coming back to the General Fund, to be voted upon at the 2023 SATM.

VOTE: that the Uxbridge Board of Selectmen declare the items listed as surplus for the purpose of sale or redistribution. All in favor. The motion carried 5-0-0.

c) Appointment: Treasurer Collector Jessica Messer - Custodian of Town Owned Land

The Board of Selectmen previously appointed Treasurer/Collector Lisa Troast to the position of Custodian of Town Owned Land; the Board needs to appoint Jessica to the similar position to authorize her to sell at auction as defined in M.G.L. Chapter 60 Section 77B.

**SECOND:** Mandile

VOTE: that the Uxbridge Board of Selectmen appoint Jessica Messer as the Custodian of Town Owned land. All in favor. The motion carried 5-0-0.

d) Annual Entertainment License: Uxbridge Youth Soccer League, 320 Sutton Street

The Uxbridge Youth Soccer League (USYL) is looking for an annual entertainment license to hold events throughout their season; Morgan Belanger was previously here to represent USYL & elaborate. Brief discussion ensued regarding the need and intention of this license.

VOTE: that the Uxbridge Board of Selectmen approve the Annual Entertainment License request for the Uxbridge Youth Soccer League. All in favor. The motion carried 5-0-0. DeMers-AYE, Wise-AYE, Mandile-AYE, Shaw-AYE, Butler-AYE

- e) Lease Agreements Review & Approve:
  - i) Uxbridge Youth Soccer League, 320 Sutton Street

The Board received clean copies of the agreements prior to the meeting, with questions answered and elaborated on by the Town Manager during the discussion of each; the parties looking to enter into the lease agreements have agreed to the final terms. Discussion ensued on questions from the Board regarding the Uxbridge Youth Soccer League; namely, section 3 (b) of the League's Lease which speaks on the requirements and expectations for the hours of access and emergency access. Ben Casper, Director of Field Management & Scheduling with Uxbridge Youth Soccer League, present in-person to represent the League and answer any questions.

SECOND: Mandile

VOTE: that the Uxbridge Board of Selectmen approve the lease agreement with Uxbridge Youth Soccer League, at 320 Sutton Street, as proposed by the Town Manager. All in favor. The motion carried 5-0-0. DeMers-AYE, Wise-AYE, Mandile-AYE, Shaw-AYE, Butler-AYE

ii) North Uxbridge Fire Museum, Inc., 313 North Main Street

Attorney Rob Knapik in-person to represent the North Uxbridge Fire Museum, Inc. Further discussion ensued regarding the Museum's Lease; specifically, the language and syntax used, referring to the Lease as boilerplate with consensus to send the Lease back to Town Counsel to eliminate legalese and create a simpler document so any lay person may read to understand it.

- f) Marijuana Host Community Agreements Review & Approve:
  - i) Apple Guy Flowers, LLC: 400R West Street Marijuana Cultivator

There are two (2) new cultivators looking to open their businesses in the Town of Uxbridge; both represented by Attorney Blake Mensing who has worked with Town Counsel on the agreements and was present to answer questions regarding the HCA's. Lucas Thayer, owner of Apple Guy Flowers, LLC, was present to answer any questions of the Board; Thayer briefly reviewed his sustainable way of gardening – the same technique he will use for the cultivation of marijuana.

VOTE: that the Uxbridge Board of Selectmen agree to enter into a Host Community Agreement with Apple Guy Flowers, LLC, at 400R West Street, and direct the Town Manager to sign said agreement. All in favor. The motion carried 5-0-0.

ii) Natural Bliss, LLC: 400 West Street - Recreational Cultivator and Product Manufacturer

Amanda Copeland, owner of Natural Bliss, LLC, present via Zoom to answer any questions the Board had. Copeland described how the Natural Bliss business plan focuses on providing safe, affordable products while prioritizing safety, with compassion and respect for the staff and community, with a dedication to hiring Veterans from Uxbridge and the Blackstone Valley.

**MOTION: Shaw** 

SECOND: Wise

VOTE: that the Uxbridge Board of Selectmen agree to enter into a Host Community Agreement with Natural Bliss, LLC, at 400 West Street, and direct the Town Manager to sign said agreement. All in favor. The motion carried 5-0-0.

g) Fall Annual Town Meeting: Tuesday, October 25, 2022 @ 7 PM – Warrant Articles, Make Recommendations, Sign Warrant, and/or Take any Action Related thereto

The Fall Town Meeting Warrant is now closed and in the Board's hands for review and signature. Representatives for the Zoning By-Laws were present: Attorney Knapik and Zoning Associate Member, Jim Blackburn. The redlined Zoning document is to be sent to the Executive Assistant, Ellen Welch, as soon as prepared. Police Chief, Marc Montminy, present to provide the Board with background on the parameters of Non-Criminal Disposition to aid in the decision of how to present this item to the tax payers at Town Meeting. Discussion ensued regarding: Uxbridge being the only Town in the area not using non-criminal disposition; what entity should be responsible for issuing the fines; what the steps of this process will look like; and, an acknowledgement that without the backing of non-criminal disposition, the fines mentioned within the Town of Uxbridge By-Laws (voted on by the same tax-payers,) serve no purpose as the fines cannot be enforced without the passing and use of non-criminal disposition. This business item will continue at the next regularly scheduled Board of Selectmen meeting: Tuesday, September 6, 2022.
