Vice Chairman Shaw called the meeting to order at 6:00 PM; the Pledge of Allegiance was recited. With no Board members in attendance via Zoom, no roll call occurred.

1. Public Hearing – Fall Annual Town Meeting Tuesday, October 25th 2022 -Warrant Articles

The Finance Committee opened and closed the Public Hearing accordingly. Pat Stephen presented Articles 14-18 regarding Citizen Petitions to Amend the Home Rule Charter and discussion ensued. Susan Franz was present but spoke as a Citizen Petitioner as she is the sponsor of those Articles.

- a. Article 14: Citizen Petition: Amend the Home Rule Charter to allow petitions for town meeting articles to be accepted during regularly scheduled office hours
- b. Article 15: Citizen Petition: Amend the Home Rule Charter to clarify the definition and usage for number and gender
- c. Article 16: Citizen Petition: Amend the Home Rule Charter to require at least five members to serve on specific multi-member bodies holding certain regulatory responsibilities
- d. Article 17: Citizen Petition: Amend the Home Rule Charter to increase the number of elected members to the finance committee by one and decrease the number of appointed members by one and adjust the terms and method of selection
- e. Article 18: Citizen Petition: Amend the Home Rule Charter to Make the town managers annual performance review a public record






