1. Public Hearing – Fall Annual Town Meeting Tuesday October 25th 2022 -Warrant Articles

Finance Committee Member Franz recused herself as she is the Citizens' Petition Sponsor for the Articles discussed: Articles 19-22. Pat Stephen presented those Articles regarding Citizen Petitions to Amend the Home Rule Charter, supplemented by PowerPoint presentation. Discussion ensued among all present, to include the Town Manager, Board of Selectmen, and Finance Committee.

- a. Article 19: Citizen Petition - Amend the Home Rule Charter to adopt procedures to review and/or retire multi-member bodies and advisory committees
- b. Article 20: Citizen Petition - Amend the Home Rule Charter to clarify procedures for multi-member bodies regarding email notifications, minutes, and compliance with General Laws, the Charter, and Bylaws
- c. Article 21: Citizen Petition - Amend the Home Rule Charter to extend the time to obtain and reduce the number of signatures needed for a petition to recall an elected official
- d. Article 22: Citizen Petition - Amend the Home Rule Charter regarding budgets, public budget hearings, and related deadlines to make key documents available to the public


