5) **BUSINESS**

a) Board of Selectmen acting as Water & Sewer Commissioners: Request for Approval: Lee Jundanian – Implementation of Cistern System on Kempton Road Frontage Parcel

VOTE: that the Board of Selectmen open the Water and Sewer Commissioners Meeting by Roll Call: DeMers-HERE, Mandile-HERE, Wise-HERE, Shaw-HERE, Butler-HERE.

The Town Manager received a request from Benn Sherman on behalf of Mr. Jundanian and his Attorney, Henry Lane, that he be granted the right to put the exact same cistern system in place that is currently employed in the 6 (six) lots developed right around the corner on Tabor Road. The cistern would be filled in off hours at night and only during those hours specified by the Town; further stated, this would only provide temporary relief because as soon as a (preferable) water connection with the Town is available, it would be applied for. The lot was described as being in a "No Drill/No Blast" zone, rendering well installation non-viable. Member DeMers emphasized the only time an exemption from the 2017 Water Moratorium should occur is if there's some form of water contamination.

b) Fall Annual Town Meeting: Tuesday, October 25, 2022 @ 7 PM - Warrant Articles: Make Recommendations and/or take any action related thereto

The Town Manager and Board of Selectmen are awaiting the Free Cash Certification from the state to discuss Articles 1 and 2. With no last-minute changes to their Votes or Recommendations, the Board of Selectmen had brief discussion in review of the Fall Annual Town Meeting held tomorrow.

 - i) 2022 Town Manager Goals Evaluation

The Town Charter calls for an annual evaluation of the Town Manager; Chairman Butler delivered information regarding the evaluation, including categories under review and the scores that were tabulated. There were ten (10) categories that comprised the Town Manager's Evaluation; all categories were reviewed and announced at the meeting, including the tabulated averages for each. ii) BOS Policy Review: Alice Bridges Bridge - Establish Policy

The Town Manager's Office has received a number of both positive and negative calls regarding the flags, etc. that have been placed on the bridge. A question of who has the authority to allow flags etc. to

be placed on the bridge has come up so there is a need for a clearly defined policy regarding who allows anything and what and how that would be allowed. Further discussion ensued regarding the establishment of this Policy; the Board of Selectmen will work further towards a final document to be read and accepted at a future Board of Selectmen meeting. The Town Common Bulletin Board Policy was referenced for example as way to draft the Alice Bridges Bridge Policy.

iii) Uxbridge Legal Counsel Discussion

Members Wise and DeMers recently had a conversation with a potential new vendor for legal services and provided the Board with an update from that discussion. TM Sette provided the Board with more background on the meeting and aspects of the evaluation. Legal bills from the last year were reviewed to prepare for a decision after service comparison; the retainer for legal services was requested for review and comparison as well. Discussion ensued with favor to the potential new vendor as it's of a team of attorneys with varied specialties; the Board will revisit this discussion for further collaboration.
