1) CALL TO ORDER & SALUTE TO THE FLAG

The meeting was called to order at 6:30 PM by Mr. Butler. The Pledge of Allegiance was recited.

Due to the current Coronavirus emergency and social distancing, Board members may be attending Board meetings remotely; all votes will be via roll call. Additionally, the remote meeting technology, Zoom, was utilized for this meeting.

b) **Uxcellent News:**

- Mr. Plasko offered a special thanks to Koopmans, who received about 5,000 masks. Rather than place on the shelves, they instead donated to healthcare facilities, first responders, hospitals.
- ii) Mr. Plasko also shared that on Sunday the Uxbridge Fire and Police departments responded to a residence where a woman was in labor and ready to deliver. - DPW Update by Director Benn Sherman
 - Mr. Sherman updated the Board on a number of projects that the DPW will be managing this Spring/Summer. Mr. Sherman and Board members discussed many projects on the list, among them: East Hartford Ave., West Hartford Ave., Rivulet, Granite and Oak streets, the wastewater treatment facility construction project, the State project on North Main and Douglas streets, the weight limit on the Homewood Ave. Bridge, Albee Road flooding issues and the Hecla St. bridge. Mr. Sette will arrange a meeting with Chairman Butler and Mr. Sherman.
- Authorization for temporary easement license to NGRID- West River Pump Station Mr. Sette and Mr. Sherman provided details on this easement request.

MOTION: Mr. Plasko moved the Board of Selectmen grant a temporary easement to license NGRID for the West River Pump Station. Seconded by Mr. Shaw. The motion carried 5-0-0 via roll-call vote: Plasko-yes, Shaw-yes, Butler-yes, Franz-yes, Mandile-yes.

Inspection Fee Increases (Building Inspector Larry Lench)
 Mr. Lench was not in attendance; Mr. Sette suggested this item be tabled to the next meeting.

MOTION: Mr. Shaw moved the Board of Selectmen delay the Inspection Fee increases until the next regularly scheduled Board of Selectmen meeting. Seconded by Mr. Plasko. The motion carried 5-0-0 via roll-call vote: Plasko-yes, Shaw-yes, Butler-yes, Franz-yes, Mandile-yes.

d) Committee/Board Appointments
The Board was asked to appoint to the following open committee/boards: A Poll Worker, Open
Space Committee members, and Council on Aging. Mr. Butler advised that the Open Space
Committee appointments is tabled to the next regular meeting.

g) Town Common Use Approval: BSA Troop 1122 – April 25, 2020, 8:00 AM – 3:00 PM Plant Sale The Boy Scouts of America Troop 1122 is requesting approval to use the Town Common on April 25, 2020, from 8:00 AM – 3:00 PM for the purpose of holding a plant sale.

MOTION: Mr. Plasko moved the Board of Selectmen approve the request from Boy Scouts of America Troop 1122 for April 25, 2020, from 8:00 AM to 3:00 PM. Seconded by Mr. Shaw. The motion carried 5-0-0 via roll-call vote: Plasko-yes, Shaw-yes, Butler-yes, Franz-yes, Mandile-yes.

h) Review & Approve EEO Policy and Reasonable Accommodations Form Mr. Sette provided the board with details on this request. Both items will be part of the formal employment package.

Declaration of Town State of Emergency
In conjunction with the Governor's declaration, the Town Manager requested the Town of Uxbridge declare a State of Emergency which will allow the Town to take certain actions, if necessary, to protect the health, safety and welfare of our residents. Mr. Plasko read the declaration to all present.

MOTION: Mr. Butler moved the Board of Selectmen declare a State of Emergency in the Town of Uxbridge as requested by the Town Manager. Seconded by Mr. Plasko. The motion carried 5-0-0 via roll-call vote: Plasko-yes, Shaw-yes, Butler-yes, Franz-yes, Mandile-yes.

4) TOWN MANAGER UPDATE

COVID-19 Update (Health Director Dr. Kristin Black and Chief of Police Marc Montminy)

Dr. Black provided a status update. The Town's web site has been updated to include COVID-19 information - www.uxbridge-ma.gov/covid-19. Working Groups are being formed who will be working with the Town's Emergency Management Team. The daily meetings with Dr. Black, Chief Montminy and Mr. Sette continue. Dr. Black is now looking into engage volunteer groups to ensure they are best meeting the needs of the community, using resources, and combining efforts. Also, work is being done on improving and building out the web site to include resources for businesses with financial hardship related to COVID-19. Discussion was held regarding Board of Health staffing levels.

Chief Montminy thanked a few local businesses that have donated PPE supplies to the Town, including Onsite Computers, BJ's Wholesale Club, and Koopmans. The Chief also provided an update on the department's activities.

Mr. Sette shared the Governor's order of March 23, 2020, and the Town's response. Mr. Sette updated the Board on other Coronavirus-response activities, including regular conference calls with other town managers, mayors, and the Governor's office, as well as a conference call hosted by Representative Soter and Senator Fattman with the towns they represent. Mr. Sette thanked everyone for their support and all the work being done and assured the Town residents that all are doing the best they can to ensure the Town is taken care of. The Board members offered their support and thanks to all staff.
