1) CALL TO ORDER - Butler called the meeting to order at 6:31 PM. The Pledge of Allegiance was recited.

 - i. Mass, Electric Co. to install new poles at 38-48 on Williams Street
 - ii. Joint petition from Mass. Electric Co. & Verizon to install a mid span pole 42-50 on Sutton Street and to relocate poles 32, 39, 41, 42 on Sutton Street

VOTE: to continue the Public Hearing for the two Pole Hearings for new poles at 38-48 Williams Street by Mass Electric and the joint petition from Mass Electric & Verizon to install a mid-span pole at 42-50 on Sutton Street and to relocate poles 32, 39, 41 and 42. All in favor. The motion carried 3-0-0.

c) Street Name Request: Sherman Way – review, approve

The Public Safety Committee has approved the new street name request of Sherman Way as it meets the Board of Selectmen policy and is named for an Uxbridge Veteran currently on the Wall of Honor. Action on this request was

continued to this meeting due to a question on Sherman Way versus Elm Street Extension. Here with Turning Point Engineering and as a representative of the applicant, Stephen O'Connell provided the Board with further background.

VOTE: to deny the request of the applicant for the name of Sherman Way and continue this development as a continuation of Elm Street. All in favor. The motion carried 3-0-0. DeMers-AYE, Wise-AYE, Butler-AYE

d) Extension of Road Closure for Albee Road culvert construction to 12/17/21

Sette expressed the need to extend road closure for the repair of the Albee Road culvert repair until December 17th. Discussion ensued and Board Member DeMers reviewed importance of work completion and communication on such.

VOTE: to approve the road closure extension from December 7, 2021 to December 17, 2021 for Albee Road. All in favor. The motion carried 3-0-0. DeMers-AYE, Wise-AYE, Butler-AYE

e) Pine Ridge Estates - Proposal for 36 home single-family residential development pursuant to M.G.L. Ch. 40B located at 354 & 358 Douglas Street – review

The developer provided the Board with an overview of a 40B LIP project they're proposing for 354 and 358 Douglas Street. Stephen O'Connell, Turning Point Engineering, on behalf of Eastland Partners, with Chad Boardman, Eastland Partners *General Manager*, and Clayton Williams, Eastland Partners *Director, Planning & Sustainability* reviewed PowerPoint and answered questions on this affordable housing project. Discussion ensued among the Board on impact to Town and changes the Board would like to see before their approval of partnership on the project.

g) Donations: COA - Lennie & Marcia Metcalf, 300 Richardson Street, \$300 In Memory of Leonard Metcalf

The Council on Aging received a \$300 donation from Lennie and Marcia Metcalf in memory of Leonard Metcalf. The Board of Selectmen extend gratitude to Lennie and Marcia Metcalf for their generosity in Leonard's memory.

- h) 2022 License Renewals vote
 - i. 2022 Alcohol, Auto Amusement, Common Victualler, Class I-III, Entertainment, Precious Metals
 - ii. Surrender of Beer & Wine On-Premise License: Papa Gino's

Annually the Town approves various Alcohol, Common Victualler, Class I-III, Amusement, Entertainment, Innholders and Precious Metal licenses, provided their paperwork is complete and there are no other outstanding issues that need attention. Brief discussion ensued among the Board to ensure all License Renewals had been fully vetted. The Board discussed an amendment to the Class III Licenses to add a Hazardous Materials stipulation, noted in Vote.

VOTE: that the Board of Selectmen approve that the table under 4 H subsection (i) be submitted for renewal of licenses pending resolution of all inspections, taxes due, and any other outstanding issues for all Alcohol, Auto Amusement, Entertainment, Common Victualler, Class I-III, and Precious Metals Dealer licenses with the stipulation that the Board receives notice at the first meeting in January that all are up-to-date or the license will not be issued; with the stipulation of Class III to include evidence of reclamation program for Hazardous Materials. All in favor. The motion carried 3-0-0. DeMers-AYE, Wise-AYE, Butler-AYE
