a) <u>Public Hearing:</u> License for Storage of Flammable, Combustible & Explosive Materials: Myron Trujillo, 79 River Road

Myron Trujillo, with Osterman Propane, present via Zoom as the representative for this license; Trujillo answered questions of the Board to clarify pertaining license information.

VOTE: that the Public Hearing for this matter be opened. All in favor. The motion carried 5-

b) Special Municipal Employees: Dissolve, Town Clerk

The Board has discussed this policy issue in the past and to clarify all confusion, it was suggested that each Special Municipal Employee matter be taken individually as the need arose; Kelly Cote was present to discuss this matter and ask the Board to dissolve the previous vote.

c) Road Acceptance Plan: Maslow's Way

This matter was approved at the Spring Annual Town Meeting and the Board now needs to accept the vote and sign the mylars.

VOTE: that Board of Selectmen accept the Spring Annual Town Meeting vote regarding Maslow's Way, making it an official Town road and sign the mylars to that effect. All in favor. The motion carried 5-0-0. DeMers-AYE, Wise-AYE, Mandile-AYE, Shaw-AYE, Butler-AYE

d) North Uxbridge Fire Museum, Inc.

Attorney Rob Knapik was present to discuss this proposal with the Board of Selectmen and to provide all the background information and plans for the future of this Museum. Discussion ensued among the Board; the Board agreed to support this proposal moving forward.

Present via Zoom, Chief Montminy reviewed the need for Traffic Constables as discussed at a previous meeting. A vetted list was provided by Chief and now needs a vote of approval from the Board. Further discussion regarding the parameters of Traffic Constables ensued; Traffic Constables are to serve for a three (3) year tenure.
