Joint meeting with the Board of Selectmen

Call to Order: 6:30 pm

- 1. Public Hearing Fall Annual Town Meeting October 22, 2019 Warrant Articles Chair opens public hearing
  - a. Article 6: Capital Purchases/Projects
     Interim Town Manager Peter Hechenbleikner stated that FY19 free cash will not be certified for the FATM.

Chief Dion presented the request for a new command vehicle to replace M3, a 2011 former police cruiser.

DPW Director Benn Sherman presented the request for a new trackless multipurpose machine, a 1-ton dump truck and an electronic message board. Some members asked for additional quotes for the trackless machine, including used machines. The DPW vehicle fleet size, age and condition was discussed. The Capital Committee did not review any of these proposals.

- b. Article 15: Citizen's Petition accept Tucker Hill Road as a public way Jim Smith presented the article. A significant number of items need to be completed before the road is ready for acceptance.
- c. Article 16: Citizen's Petition rescinding solid waste and recycling enterprise fund Jenn Modica presented the article. Discussion focused on the most appropriate type of fund for this operation, an Enterprise or Revolving fund. Dr. Tapscott, BOH member, provided his comments regarding a town wide solid waste and recycling program.
- d. Article 14: Adoption of Wetlands Bylaw
  Conservation Agent Holly Jones presented the highlights of the proposed bylaw with
  Con Com member Andrew Gorman. Discussion focused on the various
  classifications of vernal pools.
- e. Article 4: Authorizing the BOS to sell, exchange or transfer a parcel of land on South Main Street, assessors map 30 lot 4543 on Millville Road

Interim Town Manager Peter Hechenbleikner presented the article. The sale of this property could benefit a proposed small business development project on adjacent parcels.

- f. Article 7: Bills of prior fiscal year Passover – No prior year bills
- g. Article 13: General Bylaw Amendment date of annual town meetings for election of officers


Interim Town Manager Peter Hechenbleikner presented the article. The bylaw was never added to the General Bylaws when it was passed by Town Meeting years ago.
