1. Public Hearing – Spring Annual Town Meeting May 15, 2021 Warrant Articles (continued from 4/14/21)
  - a. Article 6: Town Budget
    - i. Human Services: 610, 510, 541, 543  
Library – Library Director Chris Powloka reviewed his budget request.  
Board of Health – Health Agent Erin Hightower reviewed the budget and with BoH member Dr. David Tapscott and talked briefly about the vaccination clinic.  
Council on Aging – Director Lisa Bernard reviewed the Senior Center budget and operations.  
Veterans Services – AnnMarie Cleary presented the budget for her department.
    - ii. Regional Schools: 380, 381, 382  
BVT Superintendent Dr. Michael Fitzpatrick reviewed the budget assessment to Uxbridge and discussed revolving accounts and grants.

League President Bryan Kindl and Ben Casper spoke about the League's difficulty at times with securing town fields, leading to the desire to sign a long-term lease with the town for the property at 285 Sutton Street.
- c. Article 17: Grant of Easement for the Purposes of Establishing a Bike Path  
Bob Contursi from the Blackstone Heritage Commission spoke about their efforts to extend the bikeway thru Uxbridge and the need for easements on town property. They explained the need to have easements in order to pursue funding.

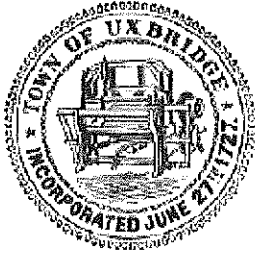

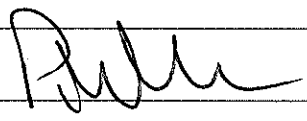


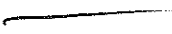
