1. Public Hearing – Spring Annual Town Meeting May 15, 2021 Warrant Articles (continued from 3/30/21)
 - a. Article 15: Adoption of Chapter 60, S23B Raise Municipal Lien Certificate Charge
 - i. There was discussion of the basis for the increase to \$50.00.
 - ii. There was a concern expressed that the language of this section does not allow more than \$50. It was suggested this be reviewed to ensure it accomplishes what the intent is.
 - b. Article 21: Citizen's Petition – Rezoning of Summerfield at Taft Hill
 - i. Patrick Stephan from Summerfield spoke about the petition. He stated the property owned by Summerfield has two different zoning designations and they are trying to get it to one designation.
 - c. Article 24: Citizen's Petition – Extend Age Restricted Overlay District
 - i. David Eldredge spoke about this representing the petitioners. He informed the Committee that due to missing language that is needed the Article will be withdrawn and re-submitted for the next Town Meeting.
 - d. Article 9: Cable PEG Access Television Enterprise Fund Budget
 - i. TM Steve Sette presented the budget for this Enterprise with support from Barry Giles. There was discussion of the revenue stream and the future of it to cover the expenses.

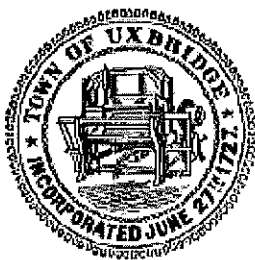
