Call to Order: 6:30pm

- 1. Public Hearing Spring Annual Town Meeting June 17, 2020 Warrant Articles
 - a. Article 5: Town budget
 - i. Library
 - 1. There is an increase of \$2,820 for Building Repairs & Maintenance
 - 2. There is an increase of \$4,295 for Building Systems
 - 3. There is an increase of \$500 for Technology Support Services
 - ii. Veterans
 - 1. Payroll was discussed
 - iii. Police Department
 - Biggest difference in this budget is a more accurate statement of overtime and shift coverage resulting in a \$150,000 increase
 - 2. There are 3 vehicles to be purchased this year
 - iv. Fire Department
 - 1. Budget includes the Chief's salary as well as the future contract with the firefighter's union
 - 2. Additionally, the overtime line has been updated
 - v. Board of Health
 - 1. The BOH voted to make the Health Director position full time
 - 2. The budget is up \$18,000
 - 3. Budget item 5110 salaries was heavily discussed
 - b. Article 24: Establish drug awareness task force
 - There is \$5,000 dedicated to establishing a drug awareness task force in the budget to allow for officers to go into the school system to provide drug abuse education.
 - Blackstone Valley Tech's Regional School annual budget was presented by BVT Superintendent Dr. Michael Fitzpatrick
