Town Manger indicates Warrant comprised of 16 Articles including 3 Citizens Petitions, and 2 related to zoning.

#### Article 1 – Transfer to Stabilization

- FC Chair highlighted the need to review the composition of the current Stabilization balance
- Town Accountant Michelle Laramee stated the current stabilization amount (\$5,067,192.13) is free cash from the prior two fiscal years
- Town Accountant will verify if the Marijuana Community Impact Fee needs to go into separate account and if there are any restrictions regarding how the funds are spent

## Article 6 - Establish Drug Awareness Task Force

- Chief of Police discussed what activities are presently in place, which have been done without any dedicated funding
- Discussion about how the \$5000 sought is going to be used
- Proposed task force activities to be included in the article description

## Article 7 – Employee Compensation Study

- Last study was done was 5 years ago
- Town Manager explained the necessity for the study, including limiting employee turnover, making the Town more competitive, illustrating worth of all positions, including benefits package
- Fin Com Chair expressed the need to have annual employee reviews conducted at every level

## Article 8 - Lease of Surplus Property-59 Hazel Street

- Held over to next meeting on 9/30/2020
- Town Manager to provide further information related to this Article, clarification of certain items and request to Michael Gallerani, Uxbridge Economic Development and Community Planning, to be present at the next meeting.

## Article 11 - Grant of Easement: West River Pump Station-145 Hecla Street

- Town Manager discussed easement location including erection of 1 new pole and content of easement document


