Continuation of Public Hearing for Fall Annual Town Meeting 10/27/2020 Warrant Articles

Article 2: Transfer to Capital Stabilization Fund

- Town Manager provides overview of transfer
- Discussed transfer amount and fact that Free Cash has been higher in past two years than in prior years
- Town Manager provides background on what the higher transfer would accomplish insofar as bond rating, etc.
- Lisa Troast reviews her memo re: Cap Stab Transfer
- Discussed whether initial transfer amount would be enough for upcoming fiscal year
- Discussed whether 3.4 million as the initial deposit into Capital Stabilization would be reasonable

Article 3 – Acceptance of Stabilization Fund Provisions

- Article allows Town to dedicate a certain percentage of funds received to a established Stabilization Fund
- Article only allows for transfer and does not provide a specific amount for transfer
- Must readopt every 3 years

Article 4 - Revenue Dedication to Capital Stabilization Fund

- Dedicate 50% of annual cannabis tax
- For FY 2020 the cannabis tax amount was 386,852

- Transfer would be effective beginning FY 2021

- Lisa Troast discussed how the 50% amount was determined

- By law the amount has to be a minimum of 25%

- Discussed how many businesses currently in existence and how many are slated for future opening
- Discussed Community Host Agreements and need for sunset provisions
- The amount can be reviewed and changed in future years

Article 9 - Establish Re-adopt OPEB Trust (M.G.L. c.32b, §20)

- Allows BOS to create Trust Fund and other items

- Need to have a good presentation at Town Meeting so voters understand the full impact of the article
- The Trust document ensures funds will be protected and the money will only be allocated to post-employment benefits
- Everyone agreed this was a necessary Article
- Discussed meals tax dedication to OPEB

Article 16– Citizen's Petition – To No Longer Charge Cannabis Retail Businesses a Community Impact Fee (CIF)

- Presentation by Stephen Mandile who discussed the merits of the article
- Impact on consumers and retail businesses only
- Discussed how the loss of revenue would impact the Town budget
- Town Manager discussed licenses and how they are allocated with Host Agreements
- Discussed how money from CIF can be spent
- Sponsor indicated that the CIF fee is only set for five years per the length of the Host Agreements
- CIF can be renegotiated as part of Host Agreement renewal
