Questions and issues by BOS and Fincom Members addressed and discussion re: amending the Motion at Town Meeting to better address the housekeeping intent of this Article. Current Board's that should be closed-Mr. Stephan and/or Mr. Sette will provide Fincom and BOS with a list.

Article 20: Citizen Petition Amend The Home Rule Charter to clarify procedures for multi-member bodies regarding email notifications, minutes, and compliance with General Laws, the Charter, and Bylaws. Discussion re the benefit of keeping the requirement of 20% of all voters signature and how that compensates for the proposed removal of the 25% of all eligible votes voting requirement for passage. SF indicated over past 10 years Town has never met the 25% of all eligible voters requirement in any election.
