Mr DeMers has questions on construction warranties due to the delays


#### 2. Acceptance of minutes

#### 3. Project Update

**OPM Status Report** 

- -The mason has finished their work.
- Roofer has is installing the metal siding and fascia
- Electrical Sub. Continues to assemble the electrical room. The emergency generator has been set in place.
- Plumbing contractor is installing finishes
- HVAC Sub is starting up systems.
- Fire protection sub has flushed out system and is installing finish heads
- Drywall Sub is taping and sanding.
- Site contractor has installed some bollards and set rims and covers on sewer and drain manholes
- Commissioning agent has been reviewing submittals.
- OPM continues to coordinate site logistics with owner's vendors.
- Cable and phone companies notified to install their items
- Security and IT vendors have been onsite
- Most Subs are transitioning from rough to finish work.
- The antennae brackets have been installed





4. Schedule Update

There was discussion on the project schedule. As of this meeting, the project completion date is Nov. 24 2017 The expected completion date for the Main station is 10/16/17.

- schedule creep is not impacting budget due to liquidated damages.

- some contractors authorized to work weekends.

5. Change Order Update

 Discussion on use of the Opticom budget line to purchase extra units to support additional public safety vehicles.

Motion by Mr. Hogan to outfit all emergency vehicles with Opticom units not to exceed originally budgeted amount for these purchases, seconded by Mr. Sherman Motion carried 5-0-0.

- Discussion on work to repair/clean the south end of town hall. The committee had previously agreed to have this work investigated and to receive estimated cost. Current estimate is \$75,000. Work to expected to begin Spring 2018

  Motion by Mr. Hogan to approve moving forward with repairs/cleaning of the south end of town hall. Budget not to exceed \$100,000, seconded by Mr. Dion Motion carried 5-0-0.
- Discussion around sun damage to hose covers on equipment left in the sun for the summer due to delays.

Motion by Mr. Hogan to repair/replace components of the hose covers on equipment damaged by the sun due to construction delays not to exceed \$3,000. To be funded from the liquidated damages, seconded by Mr. Dion Motion carried 5-0-0.

- Discussion around contract extensions for PMA Consultants, Context Architects due to construction delays.

Motion by Mr. Hogan to extend the contract for PMA by 2 months at a cost of \$35,680, and extend the contract of Context architects at a cost of \$23,080, seconded by Mr. Dion Motion carried 5-0-0.
