- Electrical Sub. Continues to assemble the electrical room. Fire alarm pull stations have been installed in the admin area.
- Plumbing contractor is installing finishes
- HVAC Sub continues to rough in piping and install radiant heating panels.
- Fire protection sub has transitioned from rough to finish work.
- Drywall Sub has completed hanging all the walls.
- Site contractor has removed the boulders and cleaned up around admin area.
- Commissioning agent has been reviewing submittals.
- OPM continues to coordinate site logistics with owners vendors.
- -National Grid has installed the power connections to the transformer pad. Permanent power has been turned on.
