Cobblers Knoll:

The Board was made aware that the new town counsel has been informed about the history with Cobblers Knoll. Mr. Marinelli was present and communicated that he is committed to completing the project. The applicant is currently working with DiPrete engineering to address the items noted on the Graves report. He is working on the site distance. The applicant communicated that he went to the DPW to see if they can look at the site distance which was cleared. There were photos taken by Mr. Marinelli. The applicant continues to work with the DEP and the fine from the enforcement order will be paid and once this occurs there will be a release of the enforcement as it relates to the pond. There will need to be another inspection done by Graves. The applicants would like to complete a few additional items before Graves performs inspection. The Board would still like to continue the steps to take the bond. The Town Planner will get an update on the balance of the 53 G account.

Kathy Trail:

The Town Planner informed the Board that the Certified Letter was sent out. There has been no receipt that the letter was picked up. There is currently a surety in place of \$20,000.00. Tow Counsel is drafting language to act on taking the surety. This item will continue to be placed on the agenda for February 22, 2023.

Ledgemere Fafard Amendment to stipulations:

The Representatives from Fafard Angela Conforti and Jeff Roloff were present to discuss the revised stipulations. This document was presented to the Board. Town Counsel for the Board has reviewed the document relating to the stipulation. The Board was asked to allow for 8 more foundations on Tea Party, There is a concern that these will be uncapped. The Lots discussed were part of Phase 5. Attorney Conforti communicated that they will not be applying for the building permits for Lots 13 and 14 until the end of March until there is agreement with the town. The Board discussed that based on Graves comment from the peer review dated January 30, 2023, there are still outstanding items. Attorney Roloff communicated that that the site is in good shape with controls in place. The goal is to finish basin 3 in the spring. There was a screen share of the area.

The Board would like the applicant to provide a plan with the noted area and would like a presentation at the February 22, 2023 meeting.
