I. CALL TO ORDER

It being 9:14 am, the meeting being properly posted, duly called and a quorum being present, the meeting was called to order by Benn Sherman.

#### II. OLD BUSINESS

A. Approval of Minutes:

- a. April 17, 2018 The Board reviewed the minutes and a change to the date was made. Timothy Burke made a motion approve the April 17, 2018 meeting minutes with the correction of the date. Seconded by Benn Sherman.
  - Motion carried 2-0-1 with Angie Ellison abstaining.
- b. May 15, 2018 Board reviewed the meeting minutes.

Timothy Burke mad a motion to approve the meeting minutes of May 15, 2018. Seconded by Angie Ellison.

Motion carried 3-0-0.

B. Public Safety Committee Responsibilities.

#### C. Fourth of July Committee.

No one from the 4<sup>th</sup> of July committee was present. Discussion held and Benn Sherman will contact them to find out about the barrels that will be needed and what they will be expecting from the DPW. Angie sent a message to them in regards to DPW and Police and informing them to contact Benn and Chief Burke.

D. Review Crosswalks Hannaford's, St., Mary's, Sr. Center and other locations.

Discussed improving signage and uniformity of signs and crosswalks and Benn talked about doing an inventory of crosswalks. Discussed which crosswalks the DPW was going to move the signage to.

### A. Campanelli Business Park – Street Names

Angie discussed the value of naming new streets off the list of veterans. Tim Burke mentioned that Campanelli Drive is the main road leading into the Business Park at all their other sites. Discussion was held on the Campanelli Drive extension with a motion being made.

MOTION: Timothy Burke made a motion to recommend to the Board of Selectmen that they accept the Campanelli Drive as their main road and that Campanelli Corp. choose an alternate name from the Veterans list for the road extension. Seconded by Benn Sherman.

This will be discussed at the next meeting to make sure there are no requests that they are looking for that may need to go to the Board of Selectmen.

Discussed.

D. Pyne Sand and Stone Company, 1 Lackey Dam Road, Safety issues with trucks parking westbound. Request for No Parking signs/ Parking Prohibitive Signs.

Benn Sherman to replace the No Parking signs that are missing on both sides of Lackey Dam.

E. Resident request for speed bumps on Veterans Parkway.

Police Chief to increase Patrol in that area to limit excessive speed.
