I. CALL TO ORDER

II OLD BUSINESS

A. Approval of minutes.

B. Signage for Mendon St., hold until closed out.

DPW has everything and work will be done this week. Hold on until all installed.

C. 2nd egress for Uxbridge High School. – Update

Debate at last meeting with members of the school committee with concerns that the cost estimates from Fuss & O'Neill were not as exact as could be. Chief did not feel comfortable bringing this to the school committee as this is not his expertise and he is looking to Benn for his consideration on this. Chief will postpone a decision on this until Benn can be present to speak on it.

Steve said that Fafard is still working on this project and it should be completed.

E. State Park and Bridge Safety – Update

Committee sent a letter to the Selectboard reminding them this needed to be addressed. Steve Sette will make sure this is on the Selectboard agenda. Chief feels someone from the Public Safety Committee should be on the committee for this. Tom Dion would like to be on the committee as he has an interest in this.

F. E-Mail Douglas St. safety concerns.

Chief said Douglas St. is the most enforced road in town. Chief to put the radar sign on this street. This will be addressed. The resident was looking for a crosswalk on this corner but the committee felt this was not warranted.

A. High School Exit.

B. Myers St. parking issues.

Steve Sette said he can refer building inspector Joe Fitzpatrick to see if there are any issues there. Tom said they have been there to that house and have had no issues getting into the area. Steve will send building inspector out to make the determination.

C. MA, RI, CT, Relay

Chief saw this and has asked Lt. Burke to reach out to them. Chief said they have their act together and have this every year. Chief to report back at next meeting.




