Special meeting to discuss applications for outdoor seating as a result for COVID-19.

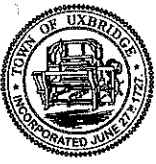
**II. NEW BUSINESS**

**A. Outdoor seating issues for local businesses.**

Proper form of application was received at 9:12 this morning and documents include: Cover letter, B.O.S. requirements, Patio guidelines, the actual application, accessibility and barriers. Board of Selectmen discussed that the application not be difficult or lengthy to complete. They asked that the Public Safety Committee only have two signatories on the document and Chief Montminy suggested he and Steve Sette be the only signatories. The Public Safety Committee will rule on the current set of applicants prior to them submitting the application that came out this morning. Future applicants will fill out the proper forms and application prior to being ruled on.

Steve Sette said if Alcohol is involved that would require a separate filing with the Town Managers Office. The liquor license will only be applicable to this year.

Kristen Black said maximum of 6 people per table.



Board members discussed the following applicants and made the following Motions.

**A.) Burger Grille:**

Steve Sette made a motion to approve application for outdoor seating for Burger Grille. They need to move tables 2' from the building without encroaching on the sidewalk. Tom Dion seconded. All approved. 3-0-0

**B.) Kapi's:**

There were no problems at this establishment. Steve Sette made a motion to approve this application seconded by Tom Dion. All approved 3-0-0

**C.) Meadowview Tavern, Blissful Meadows:**

There were no problems at this establishment. Steve Sette made a motion to approve this application seconded by Tom Dion. All approved 3-0-0

**D.) Mom's Restaurant:**

Steve Sette made a motion that tables on sidewalk in front of establishment and to the side of the driveway must have seating for 2 only. Only table to the left can have seating for 4 seconded by Tom Dion. Motion approved by all if conforming to above criteria in place. 3-0-0

**E.) Quaker Tavern:**

Tom Dion made a motion to approve with the criteria that barriers being used in place of rope. This was seconded by Steve Sette. All approved 3-0-0.

**F.) Valley Bean**

Steve Sette made a motion to approve with the criteria that barriers are placed on each end to avoid vehicles from having access to dining area, seconded by Tom Dion. All approved. 3-0-0-

**G.) The UXLOCALE**

Steve Sette made a motion to approve with the understanding that they are to confirm with barriers to protect tables, seconded by Tom Dion. All approved. 3-0-0
