Report from the Board of Health

Progress on Cleanup Day for April 28th, Green Communities initiative, municipal trash and recycling program was reviewed. The municipal water forum was also mentioned.

CLEANUP DAY

The brochure is being designed by Christine and her first draft was reviewed. Because of the amount of information needed, it was decided that an 8-panel brochure would be optimal. There was endorsement of including details about Terracycle, an organization which will redeem a variety of recyclables (toothbrushes, candy wrappers, cigarette butts, etc.). Funds can be donated to the schools. The roles of various members were reviewed. Brian, although not present tonight, is creating a poster outlining the results of the survey done by RSC. Brochures and flyers for composting will accompany the composting buckets will be printed.

Action: Deanna will approach Hannaford and Dr Swiderski about having a Terracycle station/kiosk on their premises.

SCHOOL GRANT

Linda reviewed the status of the Green Teams. Whitin is the only school which has an active one. The person who will be appointed to coordinate activity among all three schools could take on the role of coordinating and/or creating other Green teams.

PARKS and BALLFIELDS

Christine was unable to identify a party responsible among the DPW staff. Deanna was wondering about placing recycling containers at the athletic fields used by the baseball and softball association. A goal of recycling PET bottles and cans was felt to be realistic.

Acton: David will research contact person and will try to identify person or resources by April 22nd, opening day of ball season.

APPROVAL OF MINUTES


No minutes were available for review at present. March minutes will be presented at the following meeting
