A motion was made by Mr. Tuer and seconded by Mr. Pomeroy to enter into executive session to conduct strategy sessions in preparation for negotiations with nonunion personnel or to conduct collective bargaining sessions or contract negotiations with nonunion personnel. On a roll call vote, the Committee voted 5-0 to enter into executive session.

Dr. Patrick Dillon has submitted his letter of resignation and his attorney and the School Committee's attorney have developed a separation agreement for review by the parties.

Members were provided a copy of the separation agreement to review for executive session discussion. Members commented on the terms of the separation agreement.

Dr. Mobley stated that she felt the SC could have done more to repair the relationship with Dr. Dillon and that she would vote for the separation agreement because at this point it protects the district.

Ms. Stark discussed that she feels that Dr. Dillon did not want to engage in conversation to resolve the conflict. Ms. Stark expressed that she was not in agreement with several aspects of the separation agreement. She felt the committee should evaluate Dr. Dillon and that other members of the committee should be able to provide reference information if a potential employer checks references. Ms. Stark stated that she felt the committee should reach a consensus on the agreement and that it would not do so with her present so she excused herself prior to the vote on whether to sign the separation agreement or not and left the meeting at 9:35 p.m.

Mr. Tuer expressed that he was disappointed with the resignation and was frustrated with how the situation unfolded. He expressed he would vote to sign the agreement in order for the district to move on.

Mr. Pomeroy expressed a similar position to Mr. Tuer in that he wanted the district to be protected and move on.

A motion was made by Mr. Tuer to approve the separation agreement and seconded by Mr. Pomeroy. On a roll call vote the committee voted 3-1 to approve the separation agreement.

A motion was made at 9:55 pm by Mr. Pomeroy to conclude the executive session with a second by Mr. Tuer. On a roll call vote, the committee voted 4-0 to end the executive session.
