District has contracted with Vector Solutions to use Professional Development modules; January 3rd Professional Development day will specifically focus on Paraprofessionals.

Dr. Dwyer thanked Patrick Mistler for assistance with connection and set-up.

New paraprofessionals and new teachers will be able to view videos on Special Education modules; these will help set expectations for working in the classrooms.

Jessica Brittingham created videos to show teachers how to register in TeachPoint and get into January 3rd workshops; all professional development will now be accessed in one place.

Dr. Dwyer and Carolyn Rafferty, Assistant Superintendent of Bellingham Public Schools, co-taught a session on culturally responsive teaching as part of Mentor Program.

Work with DESE consultants is ongoing.
