3. International Education Exchange Funds Approval

Motion the Uxbridge School Committee appropriate \$9,500.00 from the International Exchange revolving account to be used as follows: \$4,400.00 for Uxbridge High School Spanish teaching materials and tests, \$3,600.00 for teaching materials at the Whitin Intermediate School to enhance global awareness in all social studies classes, and \$1,500.00 to cover student transportation, supplies, and materials for Taft Early Learning Center’s Grade Two International Fair to be held in May 2020 by BP. Second by KC. Vote 5-0.

Motion to have the Uxbridge School Committee approve the FY21 user fees and tuitions as follows: Athletics UHS \$150.00, Whitin Intermediate School \$100.00, no family cap and a late fee of \$25.00, no transportation fees. Preschool tuition: five-day full day \$7,000.00, five-day four hour \$5,800.00, five-day am \$4,000.00, five-day pm \$3,880.00, three-day am \$2,500.00, three-day pm \$2,350.00 by BP. Second by KC. 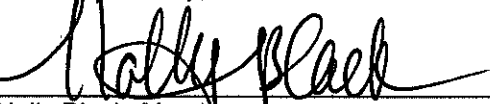
